RESERVATIONS

A block of sleeping rooms has been reserved at the hotel for arrival on Sunday, April 22, 2007, and departure on Wednesday, April 25, 2007. You may make reservations by calling the hotel at (703) 416-1600. Make sure you identify yourself as a member of the **EPA Valuation of Ecological Benefits** room block to receive the group rate. **THE ROOM BLOCK WILL BE IN EFFECT AT THE GOVERNMENT RATE UNTIL FRIDAY, MARCH 23, 2007. ANY ROOM RESERVATIONS RECEIVED AFTER THAT DATE WILL BE ACCEPTED ON A SPACE AND RATE AVAILABILITY BASIS.** Please make your reservations as soon as possible. A deposit equal to 1 night's stay is required to hold and confirm your reservation. Upon check-in, the deposit will be applied to the first night of the reserved stay. Any cancellation made by an individual must be done no later than 4:00 p.m., 72 hours prior to the scheduled arrival date. Any room cancellation made after the 72-hour period or a no-show will be charged 1 night's room and tax to the credit card on file.

DIRECTIONS

Metro:

Take the Metro to the Crystal City Metro Station (Yellow or Blue Line). Go up the escalator to the street level and turn left at the top. Proceed left onto 18th Street to Crystal City Drive. Turn left onto Crystal City Drive, walk a short block, and cross 15th Street. The hotel will be on your left. Or, upon exiting the escalator from the Metro, turn right at the top to face South Bell Street. Walk down the sidewalk on South Bell Street against the one-way traffic to 15th Street. The hotel will be directly across 15th Street.

From Ronald Reagan Washington National Airport:

Follow the signs for Route 1–Route 66 out of the airport to Route 1 toward Washington, DC. Take Route 1 North to the exit for 15th Street. At the end of the ramp, make a right onto 15th Street, which will end at Crystal Drive. The hotel will be on the left.

From Dulles International Airport:

Take Route I-66 East (Washington). Take Exit 75 (Route 110 South, Pentagon/Alexandria). Continue on Route 110 South for approximately 2 miles (the Pentagon is on the right-hand side). Take Route 1 South and stay to the right; take the 15th Street/Pentagon City exit. Follow 15th Street to Crystal Drive. Proceed beyond the light. The hotel will be on the left.

From I-95 North:

Take I-95 North. Exit onto I-395 North via Exit 170A, on the left, toward Washington. Take the VA-120 South/Glebe Road exit (Exit 7A). Bear right onto Glebe Road/VA-120. Turn left onto Jefferson Davis Highway/US-1 North. Take the 15th Street/Pentagon City exit. Follow 15th Street to Crystal Drive. Proceed beyond the light. The hotel will be on the left.

HOTEL SHUTTLE SERVICE

To and From Ronald Reagan Washington National Airport:

Shuttle hours to and from the airport start at 5:30 a.m.; the shuttle runs every half-hour until 11:00 p.m. daily. Drop-off and pick-up for the hotel shuttle is outside of baggage claim doors 5 and 9. There is a designated hotel pick-up spot for all hotel shuttles. Please call the hotel at (703) 416-1600 upon arrival, however, to alleviate the waiting time.

TAXI SERVICE

Fares to the hotel are approximately \$40–\$50 one-way for one passenger from Dulles International Airport and \$7–\$8 one-way for one passenger from Ronald Reagan Washington National Airport.
